In 2010, we had a strong presence at General Assembly (GA), advanced some key projects, increased our e-mail presence and expanded our network. One simple thing you can do to keep our membership growing is to provide a \$15 gift membership to someone in your circle.

A highlight of the year was the keynote address at our GA luncheon by Elder Rick Ufford-Chase, Moderator of the 214th General Assembly (2004) and executive director of Presbyterian Peace Fellowship. His message articulated the important role and potential of PEC as we move into a new era for the church. He said, "care for the earth is no longer an issue on the fringe," but is now "legitimately the beginning of a movement." Signs suggest that the fringe "has moved to the center," and "God's spirit is at work and the wave is beginning to crest."

In 20 years, he suggested, the issues of PEC and similar groups may be the key issues of the church. His challenges to us included: 1) Be committed to a place and a faith community for the long haul, 2) Break every taboo that you can find about crossing barriers [that divide people from each other] and 3) Take on the wildest dreams for God's vision of shalom that we can imagine. PEC looks forward to working with you in living into these challenges for years to come!
